Describe the type of change required to the Fire Code: revise existing code requirement					
Describe the problem with the existing Fire Code provision: Section 9.3 of the Fire Code is difficult to enforce and is problematic for a number of reasons such as: fire alarm and detection requirements apply to individual units - not the entire structure, inconsistent language with interior wall separations and fire-resistance ratings, confusion exists over requirements for fuel burning appliances, and a lack of a definition of kitchen facility to determine what is and what is not permitted within that room.					
Describe the proposed change or provide recommended wording: For full details please see accompanying letter sent to the Fire Marshal by the OAFC on July 27, 2021. The proposed changes would bring Section 9.3 in line with Sections 9.5 and 9.6 while allowing for leeway with other structures identified in Section 9. Current structures make it difficult to know if they're built with a 45 minute fire-resistance rating without destructive tests. The changes would also better define a "kitchen facility"
