1. Welcome

- Chief Grimwood extended a warm welcome to all members and guests and thanked Interim Chief Warner from the Niagara-on-the-Lake Fire Department for hosting
- Interim Chief Greg Warner welcomed everyone to the meeting and the new Niagara-on-the-Lake Community Centre

2. Dealing with Hoarding - John Dunn, Niagara Falls FD

FPO Dunn gave a power point presentation on the issue of hoarding. The Niagara Falls FD became involved in this issue last December and finished months later in October 2011. On December 16, 2010 the gas company contacted the police regarding a possible hoarding issue. The police in turn called the fire department and the fire crew notified the FPO. First contact was made on February 24, 2011 but the owner refused entry. Observing the outside of the building the FPO determined the property lacked the proper fire and life safety measures so used Sec 21(f) of the FPPA as the legislative tool to begin the process. The inspection order was served in person and by mail in March 2011. The content explained the order, rights and appeals. A compliance re-inspection took place on April 26th however there hadn't been any compliance with the order. Due to non-compliance, the following steps were considered:

- 1. Part 3 Provincial Offences charges failure to comply
- 2. Section 32(1) FPPA apply to the judge
- 3. Section 33(1) FPPA apply to Fire Safety Commission

The case was taken to the Fire Safety Commission who issued a decision on August 25, 2011 authorizing FPO Dunn to do work as prescribed. After much planning and coordinating between agencies such as contractors, police, appraisers, health unit and bylaw they tried to commence work on September 27th, 2011. Once again, the owner denied entry into the building. Although the decision gave permission to do the work it did not give anyone permission to enter the premise so the FPO had to go before the Justice of the Peace for a warrant to enter the building which was granted. After rescheduling all parties the warrant was executed on October 3, 2011. All work was completed by October 5th using the company Miller Restoration. Follow up will consist of a debriefing between all parties, ongoing visits to the property and the recovery of costs under Sec 35(1) of the FPPA order to pay costs. A copy of the decision was circulated for review. Currently trying to find alternative ways of dealing with hoarding as this process taxed the resources of the department and was very expensive.

5. "Lessons Learned" - Ice Rescue in Niagara-on-the-Lake

Fire Chief Rob Grimwood showed a power point presentation on an ice rescue that took place January 4th, 2011 on Lake Ontario. He gave the details of the call, actions that were taken on route and once on scene. Fire fighters searched the shoreline with TICs with no success. St. Catharines FD offered mutual aid as well as a boat so a different rescue strategy was put in place with firefighters entering the icy water to search. Eventually the child was found, taken to hospital but was pronounced dead.

The fire fighters faced the following challenges at the incident:

- Lack of initial information
- Communication issues
- Coordination issue with the Niagara Regional Police Department
- Fire fighter response issues and delays
- EMS readiness for patient
- Boat launch issue
- Use of Coast Guard boats
- Initial challenge of getting a rescue boat
- Profile and visibility of the call \(\) pressure increased as time passed
- Media and public relations
- Politics
- Well being of the fire fighters had critical incident stress debrief immediately following incident

Positive outcomes of incident:

- Coordination with SCFD good
- SCFD ice rescue operations well executed
- Dispatch did an excellent job
- Good communication and accountability between SCFD and NOTL
- Safe effective operation
- Post call management effective

NOTL came out of the situation better prepared without changing the mandate of Council's decision to do shore based rescue. Rescue was a success in light of all

the challenges but the outcome was tragic. Further discussion took place regarding water/ice rescues, level and types of service, required equipment and the ability of other agencies to respond.

6. "Lesson Learned" - Scrap yard Fire in Thorold

Chief Halladay gave a presentation on the lessons learned when Thorold and several mutual aid partners responded to a major scrap yard fire in Thorold on June 30, 2011. A map was shown explaining the various station locations and manpower available. He showed pictures to explain what was found upon arrival and the tactics used to fight the fire. Once it started getting dark and the fire was still burning, safety became a concern. The next tactic was to use grappling hooks to separate the piles and battle the blaze. MOE required the FD to manage the water so a trench and pond was dug at the SE corner of the property.

What went right?

- Communication with the public
- Reassessment and reaction changed tactics when required
- Used mutual aid
- Moved lots of water
- Held regular tactical and safety briefing in command post

Lessons Learned:

- Call external resources early
- Use Regional Fire Coordinator
- Look after yourself
- Complacency don't give up your resources
- One chief officer cannot manage a fire of that magnitude
- Challenges faced on a statutory holiday
- Improve fireground accountability system between departments
