1. Welcome

- Chief Grimwood extended a warm welcome to all members and guests and thanked Chief Mark Mehlenbacher from the St. Catharines Fire Department for hosting.
- Chief Mehlenbacher welcomed everyone and explained the location of the washroom facilities, coffee and treats. Lunch will be provided and served outside the meeting room in the Lookout Lounge.

2. Ontario Fire College Update – Transitioning to NFPA Standards and the Grandfathering Process – Doug Goodings

The grandfathering process was presented to the Fire Marshal on October 1st, 2013. Next it will be presented to the Fire Chiefs, Presidents of the Associations, etc with a communiqué out by October 15th, 2013. A certificate of compliance will be issued with credit for all the training to this point. No one can be grandfathered past a level 2. Fire Prevention Officers will only be grandfathered to level 1. The OFM is currently working on a gap process so FPOs will be eligible to receive their level 2 certification. FPO has been the only real challenge. If not happy with the certification must take the NFPA written test and skills evaluation course as of April 2014. Everyone will find a space where they fit in. All applications for grandfathering must be signed by a Fire Chief or designate and the CAO or designate must sign for the Fire Chief. New FPO process will go from Level 1 to Basic Fire Code, Level 2 to Advance and finally Level 3. Will be offering a course November 18 – 22, 2013 at the Fire College for those who want to become provincially certified evaluators. The

OFM requires a 2 year commitment from the evaluator and a contract will be signed. More courses will be offered in the future to certify additional evaluators. If evaluators are not actively involved with the training at the station level they can complete the skills evaluation within their department. The skills evaluations can be downloaded to study free of charge. The OFM will support/assist/guide and test but they will not endorse the pre-service program. All students coming out of the preservice course from all 17 community colleges will have to complete a written test and skills evaluation in order to pass. The college program will remain status quo for the September 2014 class as the program has been advertised. However changes will be made in April 2015. Private career colleges are a bit different and will be able to change their programs in April 2014. The update concluded with a question and answer period.

6. Conestoga College Pre-Fire Service Program Advisory Committee

Two representatives from Conestoga College discussed the outline of the current program and presented their ideas for changing the course offered at the college with regards to preparing students to enter into fire services. The regulatory regime is shifting and the college is preparing to be more responsive. The college wants to position the fire training program to achieve this goal and produce students with enhanced readiness. The OFM wants to see content in the programming but is silent on what else they want. The community colleges have until September 2015 to be realigned. They asked if their plan made sense to the Fire Chiefs and welcomed all suggestions to ensure they produced students ready to enter into the work force. Much discussion ensued which gave the presenters a clear understanding of what is required from the Fire Chiefs.

7. Mumford and Sons Concert - August 23 & 24, 2013 - Terry Dicks

Terry Dicks gave a power point presentation on the *Gentlemen of the Road Stopover* concert that took place at the Norfolk County fairgrounds. He discussed all aspects of the event from the inception to the planning, organizing, security, accommodation of the large crowds as well as the actual two days of the event. The band loved the area and wanted to be part of the community event. The concert was tremendously successful, well run without issue and the committee received a lot of good feedback.

8. New Business

1) One resolution and one issue for discussion was brought forward as follows:

Lee Smith proposed a resolution regarding the use of sirens during an emergency response. The Highway Traffic Act requires that personnel use both lights and sirens when responding to an emergency call. It was noted that firefighters may not necessarily need sirens in some situations during the night. It was suggested that the term "optional" be changed to "discretionary" in the

- resolution and that Rob Grimwood and Lee Smith work together on the wording before submitting. The resolution was seconded by Jeff McCormick.
- 2) Mike Seth presented a briefing document submitted to the Six Nations Elected Council regarding the WSIB presumptive legislation. Six Nations submitted their first claim under this legislation only to learn that Six Nations is not covered as they are not considered a municipality as defined under the FPPA. The issue is that Six Nations firefighters are doing the same job as firefighters throughout the province and Six Nations is making similar payments to WSIB as a municipal fire department without receiving the same level of benefits. After some discussion it was decided that Mike Seth will prepare a resolution and email to Rob Grimwood who will then forward to the group for comment.
- 3) Mike Cain and Bill Thomson unfortunately had to leave the meeting but had wanted to discuss:
 - I. MTO recognized authority for driver testing.
 - II. The MOU negotiated by the OAFC and OFM dated November 10, 2000 and whether it should be revisited as some municipalities have concerns of not being paid for response to the King's Highways.
- 4) The Canadian Motor Speedway in Fort Erie is on-site building the parking lot and staging for heavy equipment. Facility will house 65,000 seats. Will be getting some big concerts in the future. Plans for completion are 2016.
- 5) Fort Erie experienced a significant tanker truck rollover. Approximately 40,000 litres of diesel fumes were spilled but they managed to contain about 30,000 litres. The other 10,000 litres were managed with sand. Everything fell into place nicely during this incident. The Chief sent kudos to the roads operations group.
- 6) There was a near miss in Fort Erie between two planes. They managed to maneuver away but if they had connected it would have been a catastrophe.
- 7) Flying lanterns continue to be a great concern. Various Chiefs discussed their experiences in regards to this topic. Mark Mehlenbacher will see if the OAFC board have plans to address this issue and if not Zone 2 members will draft a resolution to present to the OFM to ban the possession and use of flying lanterns.
- 8) Discussed an incident at a tire recycling plant in Brantford. Some firefighters received minor burns while working in some duct work when 75% of the ceiling fell in. The Ministry of Environment was called in by Pollution Control but the Ministry of Labour was also notified but it is not clear by whom. Management has now been called to meet about this incident.
- Designated Officers Association was discussed. A newer organization that represents all emergency services. Jason Whitely will keep everyone updated on training opportunities.
