Staffing Guideline

- This is a <u>guideline</u>, not a standard
- OFM considers a "best practice"
- It can be used to analyse past calls or for pre-fire planning
- Matrix thresholds (low, moderate, high, extreme) should be pre-set use Fire Risk Sub-Model & your good judgement
- OFM is using already (e.g. Deep River, Sudbury)

Fire Prevention Guideline

- Currently under development by a working group, including fire service participation.
- Anticipated release Spring 2011

Southern Region Staffing

In 1988:

40 advisers, 80 fire safety officers on the ground

Today:

- 19 specialists for Province
- 16 advisers for Province on the ground
- SW = 4 advisers; still one adviser short

Local Projects Annual Compliance

- Overall good response
- Tip: Start early; make it a habit
- Remember: This is important documentation showing due diligence on your part (and mine)

Local Projects Mutual Aid Plans

- New: June 1st deadline for MAP submission should help prevent falling behind
- Annually: Review and update contact, equipment lists, asset report
- So far, no major changes in MAP document for 2011
