Thom Evered, OFM

- OFM staffing at 195 which is down by 33 people. Todays budget may have a further effect.
- Possibility of the Ontario Fire College and the OPP Training facility amalgamating and lands sold?
- Southwest Region has 2 Specialists and 3 Advisors. Thom has taken over Grey and Bruce Counties.
- Recent communiqués 2012-02 Care Occupancies, 2012-03 Guidance Notes – Solar Photovoltaic (PV) Systems and Wind Turbines.
- Area Projects Essentials Seminars, Essentials for Municipal Leaders and Fire Service Leaders have been combined. Let Thom know if you are interested.
- Care Occupancies procedure would be to issue an order if necessary.
- Drummond Report may mean additional layoffs nobody knows.
- Electronic Messenger will be updated daily.
- Fire Prevention guideline and workbook is now included in Essentials Seminar
- Communique on Barns being used as assembly occupancies.

- OFM Advisers will be more visible at fire scenes at the request the investigators –Question by Trent – What will their role be at a fire scene? Who's side are they on? OFM moving more to an enforcement role.
- OFM re-branding their vehicles to remove Ontario logo and replacing with OFM logo and "OFM/BCI"

Kevin Foster, OAFC

- Budgets may be the reason why Ministries cancelled out of our meeting today.
- Document on Care Facilities can be found on the OAFC Website under News Tab/Discussion Papers.
- Workbook met with the Fire Marshal Risk Management process/model re staffing at an emergency – mitigation/Fire Prevention/Response – feedback by conference. Matrix still exists today. Resource piece is very linear – doesn't allow for multi-tasking. – rit teams doesn't line up with Matrix – supporting risk management process, not just staffing, but all facets.
- Discussion re Good Roads Conference Councils want Matrix to be adopted.
- Ron Doherty has created a document explaining what services the public can expect when his department responds to an incident. Explains what the department can, and can't do, depending on manpower etc. – establishes due diligence in the community. – Needs to be addressed with the Fire Marshal.
- Professionalization cert model, met with OFM at the OFC for 2 days system attainable/ accessible - draft document being worked on.
- Drummond Report training and education commonalities between Police and Fire – what can be done where? Report suggests selling off real estate i.e. fire college.
- EMS/Tiff pilot project simultaneous dispatch Kitchener Dispatch by mid April.
- Radio Spectrum portion of 700 megahertz band ministry giving 10,
 OAFC requesting an additional 10 no changes to the 150 band.
- Sprinklers Bill to amend FPPA to require sprinklers in all Nursing Homes

 waiting for a statement from the Ministry but hasn't come due to
 upcoming election.
- OFM/OAFC Fire Prevention Committee working on a piece on enforcement
- FC Consultation 200 amendments so far not released for public comment yet OAFC requesting review prior to release to the public.
- IMS concerns where does the fire service sit? 100 and 200 levels all other agencies utilizing IMS Training program – appears fire service not

on board – IMS not intended to replace fire command – Kevin suggested going on-line and trying the IMS system – see what you think.

- OAFC looking to update website
- AMES May 5-9 OAFC May 6-7.
- No golf tournament at Glenn Abby this year nobody to take the project on
- FMPFSC couple of members on council reorganizing
- Mid-rise wood construction up to 6 storeys private members bill to prohibit the limiting of construction up to 6 storeys.

Carried

Ron Doherty – Superior Tanker Shuttle Accreditation – Using foam as an alternative to water tankers – question : would the association be willing to support councils resolution – fight with FUS , recert. every 5 years – Discussion, resolution not clear enough – what type of foam etc.

- Carl Linthorne Deputy Crothers retiring in August. call to anyone looking for a deputies position. new utility truck coming in May ambulance doing land based water rescue, high angle etc. not a good scenario. Thanks to Wayne for hosting the meeting Carl stepping down as President of Zone 3 and needs to be replaced.
